

# “Dark Money” Left-Wing Billionaire Marauders in Fairfax County, Virginia!



**GEORGE SOROS**

## ➤ **Open Society Foundation (OSF)**

- Founded in 1993 as the Open Society Institute, OSF has since become the main hub of a [Soros-funded network](#) of more than 20 national and regional foundations.
- Primary funder for **Arabella Advisors founded by Eric Kessler in 2005**. Arabella advisors sponsors at least five funds, including New Venture (NVF) and Sixteen Thirty (1630Fund)

## ➤ **Foundation to Promote Open Society (FPOS)**

- Founded and endowed by OSF in 2008 with over \$1 billion by 2009.
- Granted several projects under the NVF:
  - [Communities for Just Schools](#); focused on youth of color, LGBTQ, and immigrants. Significant contributions from the NEA and **Arcus Foundation** - advocate for gender identity policies, practices (i.e.), affirm care
  - [Social and Economic Justice Leaders Planning Group](#) – like ONE FAIRFAX mission and goals
  - Other organizations that support election law changes like early voting, police reform, and state-level redistricting.



**JOHN STRYKER**

Founder of the [Arcus Foundation](#), which established the LGBT Movement Advancement Project ([MAP](#)) to “track the complex system of advocacy and funding that would promote gender identity and transgenderism in the culture. MAP provided a strategy of support through faith organizations, sports and cultural associations, police department training and educational programs in grade schools, high schools, universities, and medical institutions. This included the American Psychological Foundation to indoctrinate trans-affirmative psychological practices.

- Arcus-funded groups and initiatives include the **Center for American Progress**, Transgender Europe, **Victory Institute**, Gay, Lesbian, and Straight Education Network (GLESN) that has influenced many K-12 school curricula, and the Sexuality Information and Education Council of the U. S. (SIECUS), which advocates for change in sex education programs that accommodates LGBTQ youth.
- [Data](#) shows that “socially transitioned” children are far more likely to go on to medical interventions like use of Zoladex (a cancer drug) for hormone treatments or eventual gender-transition surgery that can cost up to \$100,000. In 2021, the U.S. gender-surgery market was valued at \$1.9 billion, with expected 10% annual growth.
- *This is prime market for heir to medical-based franchise like Stryker Corporation.*



**HANSJÖRG WYSS**

Swiss billionaire (non-U.S. citizen) and co-owner of Chelsea FC in England. Has donated over hundreds of millions to Left-wing agendas. Early contributions started with \$1.3 million from the Berger Action Fund to the **Center for American Progress, an advocacy group founded by John Podesta and George Soros in 2003**.

- Wyss is the former CEO of Synthes (a medical device service provider) that was found guilty with partner organization (Norian) – charged over 50 felony counts for illegal experimentation on humans.
- Synthes merged with Johnson and Johnson (J&J) and later sued Stryker Corporation (company founded by John Stryker’s grandfather) under the Trade Secrets Act (or corporate espionage).
- In 2022, Janssen Pharmaceutical Companies of J&J launched the [Depression Looks Like Me](#) campaign aimed at normalizing the conversation about depression in the LGBTQ+ community.
- Conservative Americans for Public Trust filed [complaint](#) with the Federal Election Committee against Wyss, NVF (including Hub Project), 1630Fund, and Berger Action Fund for failing to file political committee and illegal campaign contributions.

- In 2020, Frisch was co-chair of President Joe Biden’s Virginia LGBTQ+ Leadership Council that incorporates and leverages resources from the **LGBTQ+ Victory Institute funded by Stryker’s Arcus Foundation.**
- The **Victory Institute** provides political and issue training, advocacy, and other resources including the establishment of the **LGBTQ+ Victory Fund that has endorsed Frisch for his ’23 School Board re-election with additional affiliations to Karl in 2019.**
- **Prior to School Board election in 2019, in August 2015, Frisch became founder of Allied Progress (AP), a sister organization to Allied Progress Action (APA), which is 1 of 45 groups operating under the Sixteen Thirty Fund.** APA received \$860,000 from labor unions to include the NEA and AFL-CIO. APA has transitioned to Accountable.US that received \$4.6 million from the New Venture Fund (NVF) in 2019.
- The February 2015 **Wyss Foundation**, “Communication Hub” development plan or The Hub Project named Frisch and Kyle Herrig as participants, representing Project Daylight. **Herrig serves on the Soros NVF Board and was strategic advisor for AP.** Other participants included the Arcus Foundation MAP and Center for American Progress.
- After working as a Partner for Bullfight Strategies (BS), **Frisch founded Karl Frisch Associates (KFA) in 2014 that supported multiple Left-wing clients to include the NVF.** The founder of BS, Eric Burns, was the former President for Media Matters for America that received billions from the Soros FPOS. *Eric contributed \$5,000 to Karl’s School Board campaign in 2019.*

**In addition to the current LGBTQ+ Victory Fund, Frisch received past endorsements from the “Squad” Progressive Change Campaign Committee and Tides Foundation, which donated over \$22 million to Soros groups from 1998-2018.**
